Frequently Asked Questions (FAQs)

1. Who can apply?

The program is open to all women members who are:

- on a career break and wish to resume their professional career
- in practice and looking for enhancing their technical and entrepreneurial skills
- in full-time employment and aiming to switch to professional practice

2. What are the benefits to join Entrepreneurship program or Why I should join Entrepreneurship program?

- Acquire required guidance for establishing own professional practice
- Gain technical knowledge on multiple service areas
- Discuss practical issues and gain first-hand learning opportunities from experts
- Discover rules of business and communication techniques
- Establish yourself as valuable support for SMEs for proper financial management
- As part of workforce, contribute in the economic development of the country

3. What is the total duration of the program?

The total duration of the program is three months.

4. How much time must I dedicate to the program?

Overall program activities have total time duration of 28 hours including online engagements through team building exercises.

5. Are all the sessions in the program compulsory?

No, but in order to reap full benefit it is advisable to attend all courses during the entire 3 months' program. However, a certificate of completion will be issued separately for each attended session.

7. How can I apply for the program?

A duly filled online registration form should be submitted along with payment confirmation.

8. If I am selected to join the program, when and how will I be informed?

Successful applicants will be notified within two working days, via the email address designated in the submitted registration form.

9. How many participants get selected in this program?

The total number of participants for this program shall be limited to 25, selection would be made on first come first serve basis.

10. Who are the mentors and trainers in the program?

The mentors and trainers of the program shall be highly experienced professionals in their relevant fields of expertise and have been selected based on their knowledge in respective topics.

- 11. Can male co-founders/ partners participate in the program?**
No, male co-founders are not eligible to participate in this program.
- 11. In which cities is this program going to be conducted?**
The program shall be for women members of ICAP located anywhere in the world. All sessions will be held through zoom online platform. However, our dedicated team members will be available in Karachi, Lahore and Islamabad in case any participation/interaction is required.
- 12. How can I join the session after confirmation of my registration?**
A Zoom link will be shared with the participants. It is mandatory to join the sessions using your email address mentioned while registration of the program along with membership number and complete name.
- 13. What type of certification I will get at the end of the program?**
Upon successful completion, each participant will receive a certificate of participation from ICAP for the topic and actual hours of courses attended.
- 14. Is there any registration fee to register with Entrepreneurship program?**
Registration fee for Segment-A is Rs.2,625 inclusive of tax and for Segment-B per session fee is Rs.1,575 inclusive of tax. Members who are interested to join all the four sessions may avail a discount by paying Rs.5,250 inclusive of tax for the complete program.
